1 **Priority 1:** Provide administrative support for improving district wide math and literacy skills through the extended use of state and federal funds.

1.1 **Goal:** The goal of the Arkansas Virtual Academy is to ensure that each school has the necessary tools to ensure that all students are performing at proficient or above on the Arkansas benchmark by the end of the 2013-14 school year.

**Benchmark:** As established in the State of Arkansas No Child Left Behind Annual Yearly Progress(AYP) Workbook, the Arkansas Virtual Academy students in grades K-5 will meet or exceed an AMO of 85.6 percent of the students proficient in literacy, students in grades 6-8 will meet or exceed an AMO of 83.8 percent of the students proficient in literacy; students in grades K-5 will meet or exceed an AMO of 85 percent proficient in mathematics, and students in grades 6-8 will meet or exceed the AMO of 82.28 percent proficient in mathematics.

Staffing: One (1) FTE highly-qualified Title I Math Coach will serve teachers, parents and students in first through eighth grades. This position will provide direct support to teachers by conducting instructional modeling sessions with students and parents. These sessions will provide ARVA teachers new math instructional strategies and/or sharpen existing strategies that are utilized with students. This math coach will also work collaboratively with all staff, administrators, parents and community stakeholders to ensure that identified areas of academic needs of students specific to mathematics are met. Title I funds will be used for salary, benefits, and professional development to include conferences in or out of state. <p>Professional development will be provided to enhance the knowledge, skills, and expectations necessary to increase student learning. Professional development will be guided by the thirteen focus areas: k-8 content area; instructional strategies, assessment; advocacy/leadership; systemic change process; standards, frameworks, and curriculum alignment; supervision; mentoring/coaching; educational technology; principles of learning/development stages; cognitive research; parental involvement; and building a collaborative learning community. Training will be provided to teachers to further enable them to support students and families in schooling effectively through a home-based public education. The content of activities will be driven by data disaggregation of state test scores, student attendance information and other data sources. State and federal professional development funds will be used for appropriate staff to attend conferences, workshops, in-services and other professional development opportunities. Funds will also be used for consultant fees, associated travel cost for conferences and workshops, materials and supplies that are needed to conduct or attend a professional development event. Funds may also be used to establish a professional resource center for teachers to have immediate access to high-quality professional resources. Professional development may include training on utilized student programs such as, k12 curriculum, Headsprout, Study Island, Scantron assessments, first aid and CPR, AETN IDEAS, IXL Math, Odyssey Math, Arkansas History, Elluminate, curriculum alignment and gap analysis. Funds may be used to provide professional development technology-related areas including the use of Study Island, HeadSprout, and Elluminate. Professional development needs will be evaluated throughout the year by utilizing on-going student assessment tools and staff and family surveys. As additional needs are identified, professional development will be provided to address identified needs. Title I funds will be used for supplemental training for teachers that may include national and regional conferences such as NCTM and Texas Instruments that relate specifically to improvement in math outcomes for students and/or practices for teaching in an online environment. <p>A technology committee has studied the LiveScribe electronic writing instrument for their possible usefulness in work sample/portfolio feedback sessions, creating tutorials and for use in Elluminate sessions as a pen input device, and as a tool to address written response outcomes from the State Benchmark exam. After presentation to teachers on possible uses, teachers were surveyed for their perceptions of the LiveScribe’s usefulness in supporting our students through creating tutorial, providing an instrument for writing in Elluminate, and most importantly, serving as a tool to strengthen our students’ writing skills, and in turn, promoting improved achievement on open-response items. A possible pilot student group will be created and will use a rubric to assess usefulness. If purchased, the LiveScribe will be on loan to all ARVA teachers and math tutors, and all students would use the LiveScribe to write more effectively during Elluminate sessions and to create written work to submit digitally to address targeted areas from state test scores and provide standards-based lessons that are aligned with the Arkansas Literacy and Mathematics Frameworks. The LiveScribe would be shipped to families. If a family withdraws from ARVA, we will pay to repair and ship the LiveScribe instrument back to the ARVA office.
