2019-20 Parent & Student Hendbooks for Insight School of Oregon Painted Hills, Cascade Virtual Academy and Destinations Career Academy of Oregon were presented.

2019-20 Employee handbook for Insight School of Oregon Painted Hills has also been updated to clear up some areas for our school was also presented.
