(Y/N)	Describe LEA Policy: Arizona Virtual Academy (AZVA) and Insight Academy of Arizona (ISAZ) are virtual schools under Portable Practical Educational Preparation, Inc. (PPEP). As such, students and staff predominantly participate in instruction from their households. For the 2022-2023 school year, in-person instruction may include local meetups at locations across the state for academic support and socialization opportunities, as well as proctored state testing offered at locations across the state. During these in-person learning opportunities, the following mitigation factors will be followed.

Modifying facilities to allow for physical distancing (e.g., use of cohorts/podding)	Y	When students are participating in in-person activities, seating will be at least 3 feet between students. Windows should remain open whenever possible. We will follow the recommendations and guidelines of the CDC, Arizona Department of Health & Welfare, and Governor’s Office regarding physical distancing.
Handwashing and respiratory etiquette	Y	When students are participating in in-person activities, hand sanitizer will be available, and, where possible, handwashing will be encouraged. Cleaning and maintaining healthy facilities, including improving ventilation	Y	Students and staff should not share materials or laptops. Any device issued at an in-person activity will be cleaned and disinfected between use by students. Surfaces such as table-tops, counters, and doorknobs will be cleaned and disinfected after a student or group of students exits an activity site. Hand sanitizer will be available at in-person activities.
Contact tracing in combination with isolation and quarantine, in collaboration with the State, local, territorial, or Tribal health departments	Y	Staff who develop COVID-19 after attending an in-person school activity or determine they had COVID-19 during the time they attended an in-person school activity must report this to their supervisor immediately. Parents/Guardians of students, parents/guardians, and/or family members or friends of students who develop COVID-19 after attending an in-person school activity or determine they had COVID-19 during the time they attended an in-person school activity must report this to the school immediately at 602-476-1320. Diagnostic and screening testing	Y	Before attending an in-person event or testing session, staff and families are asked to conduct a wellness check for symptoms of COVID-19. Any student or staff member who is experiencing or sharing a household with someone experiencing symptoms of COVID-19 should stay home. These symptoms include fever, chills, muscle pain, cough, sore throat, shortness of breath, difficulty breathing, and/or new loss of taste or smell.

### How the LEA will Ensure Continuity of Services?

PPEP will review this plan on a regular basis, and no less than every 6 months, through September 2023 to ensure that all elements of the plan are being implemented and to determine if updates are needed. If there are concerns about the plan's implementation or if there are major changes in guidance from the CDC, Arizona Department of Health & Welfare, or Governor's Office, the plan will be reviewed and updated earlier. The plan will remain on the school website through September 2023. If the plan is updated, the website will be updated with the revised plan. All stakeholder input will be reviewed and considered. The plan will be reviewed, and input will be requested at the Back-to-School Parent Meetings in Fall 2022 and Fall 2023. The administration team will review the plan in January 2022, May 2022, November 2022, and May 2023 and will bring potential updates to the board for discussion and approval, as necessary.

### Students' Needs:

Academic Needs	<p>AZVA/ISAZ will use federal funds and grants to address students' academic needs from disruptions to learning caused by COVID-19. While instruction was not disrupted at AZVA/ISAZ due to its virtual models of instruction, many transfer students have enrolled at the school with gaps in instruction. AZVA/ISAZ will use the following strategies to address students' academic needs.</p> <p><b>Expanded Summer School:</b> AZVA/ISAZ has expanded our summer school offerings for 2022 and has provided summer school courses free-of-charge to students. Summer school programs include K5 Summer Reading and Math and Middle and High School Credit Recovery. Additionally, AZVA/ISAZ will provide a paid hotspot for families with students participating in summer school upon request.</p> <p><b>Summer Enrichment:</b> All students have access to summer academic enrichment opportunities provided through AZVA/ISAZ and K12 Virtual Schools LLC (Stride K12).</p> <p><b>Tutoring:</b> We will provide live tutoring support through TutorMe for students for the 2022-2023 school year.</p>

	<p><b>Math and Reading Remediation:</b> Students will be assessed with NWEA Map Growth reading and math tests in September 2022 (or upon enrollment if they start later in the school year) to identify individual student needs and learning goals. Students who have fallen behind their peers in math or reading will receive targeted academic remediation during the school day.</p>
Social, Emotional and Mental Health Needs	<p><b>Counseling &amp; Student Support Services:</b> We will provide increased counseling and student support services to students who have fallen behind academically to support their success. All high school students will have an individual graduation plan developed by their school counselor or by their high school graduation advisor. Progress on graduation plans will be closely monitored, and support will be provided in a timely manner, as needed.</p> <p><b>Counseling</b></p> <p>We will balance time spent counseling across the three domains of student development – academic, career, and social-emotional. Counselors will utilize the Second Step program on an as needed basis for our students.</p> <p><b>SEL Curriculum</b></p> <p>AZVA/ISAZ’s Social-Emotional Learning (SEL) Site Team has developed a <i>7 Mindsets</i> SEL Learning Plan and for SY 2022-2023. AZVA/ISAZ will hold <i>7 Mindsets</i> classes for students weekly September through April. Newsletters covering the <i>7 Mindsets</i> monthly topic will be distributed to parents and staff in conjunction with each class. AZVA/ISAZ staff were trained on <i>7 Mindsets</i> in SY 2021-2022 and will participate in asynchronous staff training in August and synchronous monthly trainings for SY 2022-2023.</p>
Other Needs (which may include student health and food services)	PPEP will support student health and food services on a case by case basis and provide families with resources as needed.
<b>Staff Needs:</b>	
Social, Emotional and Mental Health Needs	AZVA/ISAZ receive quarterly SEL professional development. Staff also has access to a variety of support programs through the company health insurance.

## U.S. Department of Education Interim Final Rule (IFR)

### (1) LEA Plan for Safe Return to In-Person Instruction and Continuity of Services

- (a) An LEA must describe in its plan under section 2001(i)(1) of the ARP Act for the safe return to in-person instruction and continuity of services—
- (i) how it will maintain the health and safety of students, educators, and other staff and the extent to which it has adopted policies, and a description of any such policies, on each of the following safety recommendations established by the CDC:
    - (A) Universal and correct wearing of masks.
    - (B) Modifying facilities to allow for physical distancing (*e.g.*, use of cohorts/podding)
    - (C) Handwashing and respiratory etiquette.
    - (D) Cleaning and maintaining healthy facilities, including improving ventilation.
    - (E) Contact tracing in combination with isolation and quarantine, in collaboration with the State, local, territorial, or Tribal health departments.
    - (F) Diagnostic and screening testing.
    - (G) Efforts to provide vaccinations to school communities.
    - (H) Appropriate accommodations for children with disabilities with respect to health and safety policies.
    - (I) Coordination with State and local health officials.
  - (ii) how it will ensure continuity of services, including but not limited to services to address students' academic needs and students' and staff social, emotional, mental health, and other needs, which may include student health and food services.
- (b)(i) During the period of the ARP ESSER award established in section Start Printed Page 212022001(a) of the ARP Act, an LEA must regularly, but no less frequently than every six months (taking into consideration the timing of significant changes to CDC guidance on reopening schools), review and, as appropriate, revise its plan for the safe return to in-person instruction and continuity of services.
- (ii) In determining whether revisions are necessary, and in making any revisions, the LEA must seek public input and take such input into account
