B. Board Chair Report – Chet Edwards

C. Head of School Report – Sonimar Villegas

Enrollment updates for current enrollment and re-registration was shared for all three schools.

As of 6/16 we have 1,117 returning students for all three schools. We anticipate that number will go up quite a bit. We have 371 not returning, 140 undecided.

Academic preliminary data was shared for end of 2020-21 SY. Final data will come out in the fall. Preliminary data is showing that our combined graduation rate is sitting around 47% up from the official rate posted this January by ODE which had the combined rate at 29%. This differs from what was on the report card issued last fall which reflected a combined rate of 32%.

Insight graduation rate increased by 6.5%, ORDCA 30%.

We've improved our 9th grade on track rate for both schools when comparing it to the 18-19 rate. ISORPH 9th grade students on track data was 27%, ORDCA 45%.

This school year, we are estimating that around 65% of our Insight students are on track. This does not include those who are attending summer school/extended school.

Overall, our student progress rate in elementary, our middle school and high school course passing rates increased on average 10% semester 1 - semester 2.

NWEA reading and math assessment results were shared out for all grades K-12. We demonstrated growth across the board by implementing co-teaching and tier 2 intervention. The only area a decrease occurred was in math. In review, teacher turnover in HS Math (6 teachers this year) was a main contributing factor.

Chet congratulated Sonimar on all results of the school and final number of graduates.

Sonimar shared that Math is a barrier to high school graduation overall. What is hindering students in the 9th grade is the heavy class load on math. Based on this information and related data, we are moving to a quarter system for Insight School of Oregon Painted Hills. This will spread out Math classes for students.

We are hiring a Math Interventionist, and a Reading Interventionalist for the 2021-22 SY. These positions will be Measure 98 funded. We are also offering a math lab for credit. This lab will provide a teacher for tutoring students in the 2021-22 SY.

Sonimar explained the High School Success Consortium and why it is needed. She will sign and submit on behalf of the Board due to time constraints.

ODE summer school details and how it is funded was presented. We have a really robust summer school program we are excited about. This is being offered to high school and middle school students.

Insperty renewal. 36.75% is the service fee, nothing else has changed. This is an annual process.

Stride Alumni Service was shared. This is a free service provided by Stride. This will be shared out with all our students and families.

Gallagher Insurance renewal details were shared out along with the reason for the increase in premium. The bulk of premium increase is due to the growth of student enrollment .

The “I Understand” statement updates were shared out with the Board. This is a document that is signed at hire, annually after that.

Personnel Report for May 16-June 15. We will have many more staffing updates next month.
