B. Head of School Report – Tim Jalkanen

Head of School Tim Jalkanen shared his deep appreciate for all School Board members. All your time, efforts don't go unnoticed, it is recognized this is a volunteer position. Your Leadership and guidance is very valued. A small token of appreciation is in the mail for each of you.

Two separate Charter school application proposals were presented by Charles Wolff and Tim Jalkanen to Mitchell School District (MSD) at their most recent School Board meeting by Charles Wolff and Tim Jalkanen. Oregon Destinations Career Academy (9-12, for the first year it would be 9-11) and Cascade Virtual Academy (K-8) are the two Charters that were presented to MSD being presented. The goal is to launch these schools this spring to take advantage of the measure 98 proposals specifically for the Oregon Destinations Career Academy. MSD was very supportive of both Charter Schools.

Chet Edwards commented these two school will help Insight Painted Hills reach goals set forth last year for school improvement.

Tim shared that it is time to consider removing Libra Forde and Suzanne Strite from the school board at this time due to their busy schedules and inability to be present at school board meetings. 3-9 school board members are allowed per the By-laws of the school.

Libra Forde is the current Board Secretary, if she is no longer on the Board a new Secretary would need to be in place.

The Updated By-Laws were presented for the current Board to approve and sign. None of the By-Laws have changed, only the members listed on the last page.

The 2nd reading of JOA_Directory Information, KAB_Parental Rights, KAB-AR_ Parental Rights, AC_Non -Discrimination, AC-AR_Discrimination Complaint Procedure school board policies were shared. These are necessary to review, update and approve to keep our School Board By-Laws in line with current laws.
