



**K12 FLORIDA LLC ADMISSION AND ENROLLMENT POLICIES AND PROCEDURES IN COMPLIANCE WITH STUDENT ELIGIBILITY REQUIREMENTS SPECIFIED IN SECTION 1002.455, F.S.**

Admission and enrollment policies and procedures related to student eligibility for cyber charter schools that K12 Florida LLC (“K12”) provides virtual instruction services to, as well as for district sponsored online schools and virtual instruction programs served by K12, can be found on the disclosure website [www.k12.com](http://www.k12.com) or by linking to each school and/or program via <https://www.k12.com/florida-online-schools.html> then clicking on “Tuition-Free Online Public Schools” then clicking on "Show All”.

1002.455 Student eligibility for K-12 virtual instruction. All students, including home education and private school students, are eligible to participate in any of the following virtual instruction options:

- 1) School district operated part-time or full-time kindergarten through grade 12 virtual instruction programs under s. 1002.45(1)(b).
- 2) Part-time and full-time cyber charter school instruction authorized under s. 1002.33 to students within the school district or to students in other school districts throughout the state pursuant to s. 1002.31.
- 3) Virtual courses offered in the course code directory to students within the school district or to students in other school districts throughout the state pursuant to s. 1003.498.
- 4) Florida Virtual School instructional services authorized under s. 1002.37.

**Florida Cyber Charter Academy and Digital Academy of Florida Enrollment Services**

**K12 District Virtual Instruction Programs**

Admission and enrollment policies and procedures for district virtual instruction programs vary district by district depending on the district’s enrollment process. For instance, K12 provides support in admitting and enrolling students in some districts and may include the full responsibility for the admission and enrollment process up to final approval of enrollment, and still other districts do not involve K12 in the admission and enrollment process prior to the final approval issuance. Another difference among district virtual instruction programs is that districts vary in their document requirements.
